## HANOVER AREA YMCA 24-HOUR ADULT FITNESS CENTER ACCESS WAIVER & RELEASE FORM

Use of the Hanover Area YMCA Fitness Center outside of staffed hours of operation is for Hanover Area YMCA members only. I acknowledge that to be an Eligible Member, I must be an Adult member at least 18 years of age, have passed a criminal background check, have paid an activation fee, and must use my assigned key card to gain entrance. **Family members on my membership cannot use my 24/7 access, even if I am present. I understand if my key card is used to let anyone in or violate any portion of the Hanover Area YMCA Code of Conduct, I will lose my 24/7 access permanently and possibly lose my YMCA membership.**

I acknowledge that the YMCA HIGHLY recommends that I have an adult workout partner who also has been granted 24/7 access to the Hanover Area YMCA accompany me while using the Hanover Area YMCA 24/7 facility, but it is entirely up to me. I have agreed to pay an activation fee, which will allow me access to the Fitness Center outside of staffed hours of operation. As such, I am aware that there will be no supervision or assistance when using these facilities outside of the YMCA's staffed hours of operation. I further agree that if I am not knowledgeable in the proper use of any of the equipment, I will obtain proper instruction on the uses of the equipment prior to use or I will not use said equipment. I am also aware that if I am injured, become unconscious, suffer a stroke or heart attack or any other medical event, that there will likely be no one to respond to my emergency and this facility has no duty to provide assistance to me. Even though this facility is equipped with surveillance cameras, I acknowledge that these are not monitored to respond to medical situations or any other emergency and it is likely that should I require immediate assistance, none will be provided.

This waiver and release of liability includes, without limitation, all injuries which may occur, regardless of negligence, as a result of; (a) my use of all amenities and equipment in the facility and my participation in any activity, class, program, personal training or instruction; (b) the sudden and unforeseen malfunctioning of any equipment; (c) my slipping and /or falling while on the Hanover Area YMCA premises, including adjacent sidewalks and parking areas.

Snow and ice removal will not be completed until staffed hours of operation. As a Member with 24-hour access, I acknowledge that I can utilize the Cardio Fitness Room, but at my own risk from the elements.

I acknowledge that I have carefully read this "waiver and release" and fully understand that it is a release of liability. I expressly agree to release and discharge the Hanover Area YMCA, and all affiliates, employees, agents, representatives, successors, or assigns, from any and all claims or causes of action. I agree to voluntarily give up or waive any right that I may otherwise have to bring a legal action against the Hanover Area YMCA, for negligence, personal injury or property damage. Furthermore, I acknowledge that this Waiver and Release shall be binding on my heirs and personal representatives.

Note: Should any part of this agreement be found by a court of law to be against public policy or in violation of any state statute or case precedence, then only that wording is removed and the remainder of this agreement will remain in full force. By signing below, I give the Hanover Area YMCA permission to conduct a criminal background check on me.
